

**ACCREDITATION TERMS AND CONDITIONS OF
MOTHER OF THE NATION FESTIVAL 2025
AL DHAFRA, AL AIN & ABU DHABI**



By agreeing to share your personal information, such as your Emirates ID (EID) & passport details, you accept that this data will be used for the event & securely stored by third parties for event-related purposes.

These Accreditation Terms and Conditions (referred to as "Accreditation T&Cs") apply to the use of the Accreditation Pass for the **MOTHER OF THE NATION FESTIVAL 2025 Event** (hereby known as **MOTN**), held between **Nov 28th, 2025 to Jan 05th, 2026**, at Al Dhafra, Al Ain & Abu Dhabi, respectively.

Key Conditions for Accreditation:

- The **Accreditation Pass** is personal and non-transferable.
- It grants access only to specific areas (called "Permitted Areas") as designated by the event organizers, **BRAG & LINKVIVA**.
- The pass must be always displayed while in the Permitted Areas.
- It remains the property of **LINKVIVA** and must be returned upon request.

The **Accreditation Pass** is strictly for use during **MOTN 2025 Event**.

General Rules for Accredited Parties:

By entering the Permitted Areas, you agree to:

1. Follow all event rules, especially regarding safety and security.
2. Comply with instructions from event officials.
3. Consent to security checks for prohibited items.
4. Accept the risks of attending the event.
5. Avoid wearing or displaying political, religious, or promotional materials.
6. Allow **BRAG & LINKVIVA** to use your voice, image, or likeness in event recordings free of charge.
7. Not sell any goods (like food or souvenirs) unless you have written approval from **BRAG & LINKVIVA**.
8. Not sell or transfer your Accreditation Pass.
9. Accreditation will **not** be given to anyone under 18 years of age.

If you fail to follow the Accreditation T&Cs or event rules, **BRAG & LINKVIVA** may revoke your pass and cancel your accreditation.

Confidentiality:

All information provided to you as an Accredited Party is confidential. You must not share this information with others and should take steps to protect its confidentiality.

Recording and Transmission Rules:

For all Accredited Parties, except press, photographers, and Media Rights Licensees:

- You are **not allowed** to record or transmit any sound or images of the event for public use.
- Sharing event details (like sound, images, statistics) over the internet, TV, radio, or other media is strictly prohibited.



For Press & Photographers Only:

- You can record and share images & videos for use in newspapers, magazines, or editorial websites.
- These images must be for genuine news reporting and shared securely to prevent unauthorized access.

Use of Event Branding:

Accredited Parties can only use the event's logos and symbols according to **BRAG & LINKVIVA's** guidelines. You are not allowed to use these materials for marketing or promotional purposes without prior written approval.

Special Terms for Media Rights Licensees:

For those licensed to record and broadcast event content, additional rules apply. For further details, please contact the **BRAG & LINKVIVA Media Team**.

Reporting Lost Accreditation Passes:

If you lose your Accreditation Pass or if someone else finds it, please notify the **Accreditation Team on site** &/or contact the Accreditation Manager at rishi.khiara@linkviva.com or call **+971502634911**.

To reprint & replace a pass in case of misplaced or lost badges –

Each staff will receive only one accreditation badge. Reprints will be allowed only once in the case of a misplaced badge. A '**Replacement Accreditation Badge**' form will need to be filled out & prior management approval will be required. Should you lose your accreditation badge, you must report it to the Accreditation Office immediately.

Accreditation Pass Validity Periods:

- Live Event Pass:
 - a. Al Dhafra: Valid from **Nov 28th, 2025, 04:00pm** to **Dec 02nd, 2025, 11:59 PM**.
 - b. Al Ain: Valid from **Nov 28th, 2025, 04:00pm** to **Dec 02nd, 2025, 11:59 PM**.
 - c. Abu Dhabi: Valid from **Dec 10th, 2025, 04:00pm** to **January 04th, 2025, 11:59 PM**.
- Non-transferable, must be worn and visible at all times.

For all passes, tampering with or obscuring the pass is prohibited.

If a pass is lost, you must report it immediately to rishi.khiara@linkviva.com.

Security has the right to remove your pass if you breach any of the rules.
